OBJECTIVE OF THE CONFERENCE

The aim of the conference organizers, the Ministry of Environment of the Slovak Republic and the Slovak Environment Agency, is to create a space for sharing and disseminating information, knowledge and experience in the field of air quality, with the emphasis on goals, approaches and mechanisms in relation to achieving good air quality.

The current and potential role of the relevant state administration and self-government bodies in the air quality management system at the regional and local level will be discussed, as well as the role of air quality managers as professional support for these bodies.

As well, options and tools to support measures to reduce air pollution will be presented, in order to ensure that the permissible level of air pollution will not be exceeded. Good practices from implemented project solutions at the national and international level will also be shared.
